## WHAT YOU NEED TO KNOW ABOUT OVERDRAFTS AND OVERDRAFT FEES

An <u>overdraft</u> occurs when you do not have enough money in your account to cover a transaction, but we pay it anyway. We can cover your overdrafts in two different ways:

- 1. We have standard overdraft practices that come with your account.
- **2.** We also offer <u>overdraft protection plans</u>, such as a link to another account or a line of credit, which may be less costly than our standard overdraft practices. To learn more, ask us about these plans.

This notice explains our standard overdraft practices.

## What are the standard overdraft practices that come with my account?

We do authorize and pay overdrafts for the following types of transactions:

- Checks and other transactions made using your checking account number
- Automatic bill payments

We will not authorize and pay overdrafts for the following types of transactions without your consent.

- ATM transactions
- Everyday debit card transactions

We pay overdrafts at our discretion, which means we <u>do not guarantee</u> that we will always authorize and pay any type of transaction. If we do <u>not</u> authorize and pay an overdraft, your transaction will be declined.

## What fees will I be charged if Heartland Credit Union pays my overdraft?

Under our standard overdraft practices:

- We will charge you a fee of up to \$35.00 each time we pay an overdraft
- If your account with Courtesy Pay is overdrawn greater than \$750.00, if applicable, a daily Overdraft Fee of \$5.00 per day will be charged for each of the consecutive calendar days the account remains overdrawn. If your account without Courtesy Pay is overdrawn greater than \$35.00, a daily Overdraft Fee of \$5.00 per day will be charged for each of the consecutive calendar days the account remains overdrawn.
  - There is no limit per day on the total fees we can charge you for overdrawing your account
